Contributions to Minnesota-Bachmann Victory Committee will be allocated as follows:

1. The first \$2,400 from any individual to Bachmann for Congress Committee, designated for the primary election;
2. The next \$2,400 from any individual to Bachmann for Congress Committee, designated for the general election;
3. The next \$10,000 from any individual to the Republican Party of Minnesota;
4. The first \$5,000 from any multi-candidate PAC to Bachmann for Congress Committee, designated for the primary election;
5. The next \$5,000 from any multi-candidate PAC to Bachmann for Congress Committee, designated for the general election;
6. The next \$5,000 from any multi-candidate PAC to the Republican Party of Minnesota;
7. Contributions from non-qualified PACs will be allocated in the same manner as contributions from individuals.

Contributions to Minnesota-Bachmann Victory Committee are not deductible as charitable contributions for federal income tax purposes. Minnesota-Bachmann Victory Committee is a joint fundraising committee composed of Bachmann for Congress Committee and the Republican Party of Minnesota. All contributions permissible under Federal law that would cause a contributor to exceed any applicable federal contribution limit to a specific participant will be reallocated to the other participant to the extent permitted by Federal law in accordance with the formula outlined above. Any contribution that would cause a contributor to exceed any applicable federal contribution limit or otherwise not be permissible under Federal law will be refunded to the donor. Any contributor may designate his or her contribution to either participant, to the extent permissible under Federal law. Any contributor may make his or her contribution payable directly to either of the participating committees. Contributions from corporations, foreign nationals (without "green cards"), and federal government contractors are prohibited. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and employer of individuals whose contributions exceed \$200 in an election cycle.
